DESCRIPTION

Skim Milk Powder, Low Heat is Skimmed Milk Powder that meets composition standards defined in Codex Stan 207-1999. It is obtained by skimming milk and standardizing the protein by adding ultrafiltered skimmed milk permeate to 34% min. (w/w) milk solids nonfat basis. The standardized milk is then pasteurized, evaporated, and spray dried. The resulting powder is white to light cream color, free of hard lumps and has a sweet, clean flavor.


