GMO Status

According to E.U. Directive 2001/18, Regulations E.U. 1829/2003 and 1830/2003, *Eurosérum Skimmed Milk Powder Premium* is considered as a non-GMO product. It does not contain GMO products and does not come from GMO animals.

Non irradiation

The final product and the raw materials were not submitted to an irradiation treatment and do not need the specific labeling.

Nanomaterial

According to E.U. regulation 1907/2006 and 1169/2011, *Eurosérum Skimmed Milk Powder Premium* is not considered as a nanomaterial and does not contain any nanomaterial.

Contaminants

Eurosérum Skimmed Milk Powder Premium meets E.U. regulations 396/2005, 1881/2006 and 594/2012. It is checked for heavy metals, veterinary drugs, pesticides, dioxin, aflatoxin M1, melamine, radioactivity, benzoic acid according to a monitoring plan thus guarantee to be under E.U. regulations' limits.
